Report of the Twenty Third Session of the BIMSTEC Senior Officials' Meeting

Agenda Item 01: Opening of the Meeting

- 01. The Twenty Third Session of the BIMSTEC Senior Officials' Meeting (SOM) was held virtually in Bangkok, Thailand on 08 March 2023.
- 02. Delegations from the People's Republic of Bangladesh, the Kingdom of Bhutan, the Republic of India, the Republic of the Union of Myanmar, Nepal, the Democratic Socialist Republic of Sri Lanka and the Kingdom of Thailand participated in the Meeting. - 03. In his Opening Remarks, **His Excellency Sarun Charoensuwan**, Permanent Secretary for Foreign Affairs of Thailand cordially welcomed all distinguished delegates to the 23rd Session of the BIMSTEC Senior Officials' Meeting being held virtually. He mentioned Thailand's proposal of draft BIMSTEC Bangkok Vision 2030 as a set of priorities to guide BIMSTEC towards a prosperous, resilient and open region. He also underscored that the shared vision for BIMSTEC focuses on sustainable development, connectivity and institutional building to drive BIMSTEC towards greater regional integration and shared prosperity. He thanked the BIMSTEC Permanent Working Committee and the Secretariat for their hard work in finalizing key documents, including the Rules of Procedures for BIMSTEC Mechanisms, the Terms of Reference to establish the Eminent Persons' Group, and the draft text of the Bangkok Vision 2030, that will be submitted to the Nineteenth BIMSTEC Ministerial Meeting for their approval. - 04. In his brief Special Remarks, **His Excellency Tenzin Lekphell**, Secretary General of BIMSTEC welcomed the distinguished delegates to the Twenty Third Session of the BIMSTEC Senior Officials' Meeting. He mentioned that the Twenty Third SOM was very important and timely in terms of taking stock of progress and also in terms of brainstorming and preparing for outcomes at the Nineteenth BIMSTEC Ministerial Meeting and the Sixth BIMSTEC Summit.
